Parent/Guardian Release

By allowing my child to participate with Crush, I, the parent/guardian of the above-named player, hereby acknowledge and agree to the following terms and conditions:

- Assumption of Risk:**
I understand that participation in baseball involves inherent risks, including the possibility of serious injury. I acknowledge that while protective equipment may reduce the risk of injury, it does not eliminate the risk entirely.
- Waiver of Liability:**
I hereby waive, release, absolve, indemnify, and agree to hold harmless Crush Baseball, its organizers, sponsors, supervisors, participants, employees, contractors, volunteers, and anyone involved in transporting my child to and from program activities, from any claim arising out of any injury to my child, whether due to negligence or any other cause.
- Medical Consent:**
I give my consent to Crush, and its authorized employees, representatives, or agents, to arrange for any necessary medical treatment for my child. I understand and agree that I am financially responsible for any such medical care, which may be provided under conditions necessary to preserve the life, limb, or well-being of my dependent.
- Media Release:**
I give Crush permission to use photographs, video recordings, and/or audio recordings of my player for the purpose of documenting and promoting Crush Baseball programs. This includes the use of such materials in publications, on flyers, on the web, or in other promotional or educational materials.
- Property Responsibility:**
I agree to pay for any damages to Crush facilities or equipment caused by negligent, reckless, or willful actions by myself, my child, or members of my family.
- Conduct and Compliance:**
I agree to follow all posted rules and warnings, as well as any verbal instructions provided by Crush staff, employees, or representatives.
- Respect and Inclusion:**
My player will respect the differences and abilities of all other participants. I understand that bullying or exclusionary behavior will not be tolerated and may result in immediate removal from the program without a refund.
- Behavioral Expectations:**
I understand that if my or my family's actions during practices or games undermine the values of Crush—as outlined in the Crush "[Goals and Guidelines](#)"—my player may be removed from the program without notice or refund.
- Philosophical Alignment:**
I have read the [Matheny Manifesto](#) and understand that Crush intends to model its program on the values outlined in this philosophy.
- Roster and Refund Policy:**
I understand that not all players who try out will be selected, as roster spots are limited. By accepting a spot on a Crush team, my player is taking one of these limited positions. Therefore:
 - There are **no refunds for missed Crush events**.
 - Refunds will only be considered within **7 days of team rosters being published**.
 - After the 7-day period, **no refunds** will be issued.
- Club Commitment:**
My player is committed to playing exclusively with the Crush organization and **will not participate on any other club baseball team** (excluding Little League), unless I have received prior approval from Crush.
- Tournament Fees and Playing Time:**
I understand that:
 - Once tournament fees have been communicated to the team, **no refunds will be given**, even if my player cannot attend.
 - Payment of program or tournament fees **does not guarantee playing time**.
- Cancellations and Weather:**
I understand that there are **no refunds for rainouts or cancellations** due to weather or other circumstances beyond the control of Crush.
- High School Affiliation:**
I acknowledge that Crush is **not a feeder program for any high school**, and participation does not influence high school team placement.
- Termination Clause:**
I understand that **any violation of the above policies may result in immediate termination from the program** without notice or consideration for a refund.
