### Waiver of Liability:

I hereby waive, release, and hold harmless Crush Baseball, including its coaches, staff, volunteers, contractors, sponsors, participants, and any individuals involved in program activities or transportation, from any claim or liability for injury or damages, whether arising from negligence or any other cause.

I give my consent to Crush, and its authorized employees, representatives, or agents, to arrange for any necessary medical treatment for my child. I understand and agree that I am financially responsible for any such medical care, which may be provided under conditions necessary to preserve the life, limb, or well-being of my dependent.

I grant Crush permission to use photos, video, or audio recordings of my player for promotional or educational purposes.

### 5. Property Responsibility:

I agree to pay for any damages to Crush facilities or equipment caused by negligent, reckless, or willful actions by myself, my child, or members of my family.

### Conduct and Compliance: 6.

I agree to follow all posted rules and warnings, as well as any verbal instructions provided by Crush staff, employees, or representatives.

# Respect and Inclusion:

My player will respect the differences and abilities of all other participants. I understand that bullying or exclusionary behavior will not be tolerated and may result in immediate removal from the program without a refund.

# **Behavioral Expectations:**

I understand that if my or my family's actions during practices or games undermine the values of Crush—as outlined in the Crush "Goals and Guidelines"—my player may be removed from the program without notice or refund.

## **Roster and Refund Policy**

I understand that season fees secure a roster spot in the Crush program, not placement on a specific team. Team placement is determined by Crush staff based on player development needs, roster balance, and competitive fit. All families receive a 14-day roster confirmation window beginning on the date rosters are published for the season, or within 14 days after the first official practice of the season, whichever comes first. During this 14-day period, families may withdraw and receive a refund (minus any posted registration or processing fees). After this 14-day period, all fees become final and non-refundable, regardless of when payment was made. There are also no refunds for missed events, practices, or games. This policy ensures fairness to all families and allows Crush to finalize team counts, staffing, and field scheduling.

# 10. Club Commitment:

My player is committed to playing exclusively with the Crush organization and will not participate on any other club baseball team (excluding Little League), unless I have received prior approval from Crush. Unauthorized participation with another club may result in immediate removal without refund.

# 11. Cancellations and Weather:

I understand that there are no refunds for rainouts or cancellations due to weather or other circumstances beyond the control of Crush.

## 12. High School Affiliation:

I acknowledge that Crush is not a feeder program for any high school, and participation does not influence high school team placement.

# Termination Clause:

I understand that any violation of the above policies may result in immediate termination from the program without notice or consideration for a refund.
