Parent/Guardian Release

I, the parent/guardian of the above-named player hereby agree to the following:

1. That the information that I have provided is accurate and complete.
2. To give my/our approval to participate in any and all Crush activities, including transportation to and from the activities (if necessary).
3. I understand that participation in baseball may result in serious injuries and protective equipment does not prevent all injuries to players.
4. I hereby waive, release, absolve, indemnify, and agree to hold harmless Crush, the organizers, sponsors, supervisors, participants, and persons transporting my/our child to and from activities from any claim arising out of any injury to my child whether the result of negligence or for any other cause.
5. To hereby give my/our consent for Crush or to the employees, representatives, or agents of Crush to arrange for all necessary medical treatment for which I shall be financially responsible. This care may be given under whatever conditions are necessary to preserve the life, limb, or well-being of my dependent.
6. To hereby give my consent to Crush to take photographs, video recordings, and/or sound recordings of the above-named player in documenting the activities of the Crush. I grant Crush permission to use the negatives, prints, motion pictures, video/audio tapings, or any other reproduction of the same for Crush educational and promotional purposes in manuals, on flyers, on the world wide web, or in other publications.
7. To pay for all damages to the facilities of the Crush caused by any negligent, reckless, or willful actions by me, my child, or my family.
8. To observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by Crush, or the employees, representatives, contractors, or agents of the Crush.

I, the parent/guardian of the above-named player, also agree to the following:

- A. My player will respect the differences and abilities of all other players. I understand that bullying or exclusionary behaviors will not be tolerated and may lead to termination from the program with no refund.
- B. I understand that Crush does not take all players that try out, roster spots are limited, and that agreeing to play for Crush means that my player is taking one spot of a limited amount. Because of this, I understand that there are no refunds for missed Crush events.
- C. I/my player are committed to only playing within the Crush organization and no other club baseball team. I understand that the Crush program strives to provide a healthy balance of baseball play and rest among our teams and that playing outside of Crush is therefore not allowed unless Crush is notified in advance and agrees that it is in the best interest of the athlete and their team.
- D. I understand that after tournament fees have been communicated to the team, there are no refunds.
- E. I understand that Crush program fees may be refunded until the season's second week.
- F. I understand that paying program or tournament fees for my player does not guarantee playing time.
- G. I understand that there are no refunds for rainouts or cancelations.
- H. I understand that if any of the above policies are violated for any reason, it may result in my player's termination from the program with no refund on program fees.
